 - regular management information and ensuring that audit recommendations regarding major weakness of management are implemented
 - the Group's accounting policies
- 3. To recommend to the Board the appointment of the external auditors



STRATEGIC AUDIT PLAN

The Strategic Audit Plan is prepared to set out the objectives and responsibilities of Internal Audit Division, and to assist the Audit Committee in discharging its responsibilities as required by the Kuala Lumpur Stock Exchange.

Regular audits on the company and each of its subsidiaries controlled by the company shall be done in accordance with the Strategic Audit Plan. The Audit Committee has approved the Strategic Audit Plan for the year 2000 in its meeting held on 23 March 2000. The Board or the Committee can also request for special audits to be conducted where deemed fit and necessary.

1999 REVIEW

In 1999, the Committee held three meetings and conducted a total of seven audits for the year under review. For these audits, emphasis was placed on the review of operational aspects of the business, which included strategic organizational and managerial audits, performance and efficiency audits of Bumi Armada Berhad Group.
