On behalf of the Board of Directors, I am pleased to present the Annual Report and Accounts of the Group for the year ended 31 December 1999.

REVIEW OF RESULTS

The Group's turnover for the financial year 1999 increased by 33% from RM54.146 million to RM71.949 million. The Group recorded a pre-tax profit of RM5.804 million, which represented an increase of 434% against the pre-tax profit of 1998 of RM1.086 million. The improved profitability is mainly attributable to the continuing cost control measures, efforts made to increase productivity and the increase in turnover due to the improving economy.



PROSPECTS

The Directors expect to focus on increasing productivity and efficiency in order to remain competitive. Barring unforeseen circumstances the Directors expect satisfactory results for the year in view of the continuing recovery of the Malaysian economy.

DIVIDEND

The Board is recommending a first and final tax exempt dividend of 3% for the financial year ended 31 December 1999.

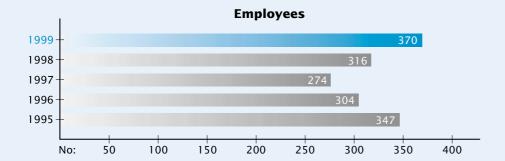
