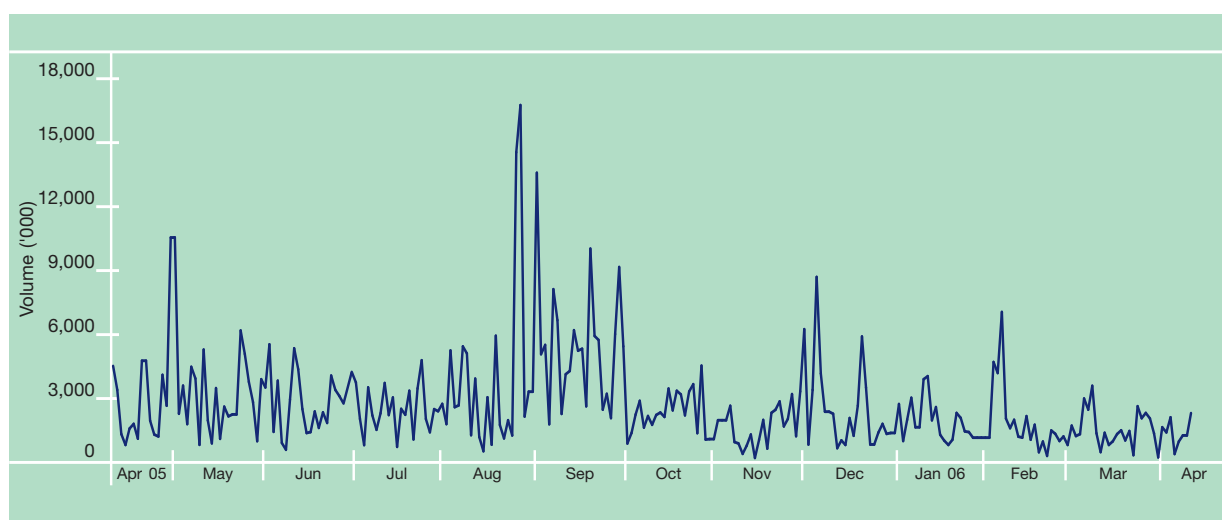
<b>May 2005</b>	Announcement on 25 May 2005 of the unaudited consolidated 1st quarter results for the three months ended 31 March 2005.

## JANUARY

- 04 Maxis was the **FIRST** to offer MMS Traffic Check service to subscribers.
