Syarikat akan terus mempertingkatkan kebolehpercayaan, kecekapan, kekekalan dan keteguhan pemprosesan dan penyaluran gas serta kemudahan utiliti perindustrian.

Masa hadapan menawarkan peluang dan cabaran. Pada bulan Ogos 2002, syarikat mula menerima gas yang diimport daripada Natuna Barat, Indonesia yang menandakan satu lagi langkah penting ke arah merealisasikan rangkaian saluran paip gas merentasi ASEAN. Hubungan antara infrastruktur gas merentasi sempadan yang semakin berkembang di Asia Tenggara memberi peluang untuk menggalakkan keselamatan, kekekalan dan jaminan bekalan gas lantas memberi dorongan kepada PGB untuk memperkembangkan perniagaannya terutama dengan bertambahnya import gas dari projek Lembaga Pembangunan Bersama Malaysia – Thailand yang sedang dilaksanakan. Kami yakin bahawa Syarikat kami berdiri teguh dan berada dalam landasan untuk menuju ke arah matlamat kami untuk menjadi "Syarikat Pemprosesan Dan Penyaluran Gas Pilihan Yang Utama".

Prospects

PGB has grown from a gas processing and transmission arm of PETRONAS to a public listed Company with the completion of the PGU trans-peninsula pipeline and loop systems, gas processing capacity expansion and diversification into industrial utilities. The Company approaches its 20th anniversary in a vantage position in terms of its strong commercial viability and potential for business growth.

With an initial processing and transmission capacity of 250 mmscf/d of sales gas, it has expanded well beyond 2,000 mmscf/d with the PGU pipeline system spanning the peninsula. The Company is well positioned to enhance shareholder value through more efficient and cost effective operations as processor and transmitter of sales gas and products for PETRONAS, and in the manufacture and marketing of industrial utility products to meet customer demand.

As the vital link in the delivery of gas and liquids from upstream suppliers to downstream customers and provider of centralised utility facilities to the gas-based petrochemical industries, PGB is well aware of its important role in enhancing the gas business value chain. It will continue to enhance the reliability, efficiency, sustainability and robustness of our gas processing, transmission and industrial utility facilities.

The road ahead offers opportunities and challenges. In August 2002, the Company began receiving imported gas from West Natuna, Indonesia, marking another important step towards the realisation of the Trans-ASEAN Gas Pipeline network. The growing interconnection of cross-border gas infrastructure in ASEAN offers opportunities to boost security, sustainability and reliability of gas supplies, giving PGB the impetus for growing its business especially with further import of gas from the Malaysian-Thailand Joint Development Authority project currently
